

RETURN FORM PROCEDURES - PUERTO RICO

The Return Form addresses the issue of misloaded and unidentified cartons found on the inbound loaded containers.

- The following clarifies the exceptions:
 - Cartons without a ship to store shipping label the cartons have a shipping address of Jonesville, NC.
 - > Unlabeled cartons cartons without any label.
 - Misloaded cartons the cartons have a shipping label; however, they are not intended for your delivery area. They should have been shipped to another carrier.
- The Return Form (see **Exhibit H** for an example) must be completed and e-mailed within 24 hours of the inbound freight being processed. Any cartons received for stores outside of your delivery area, without labels, or with only a Jonesville label are to be listed as "misloads" on the OS&D Report, as well as being listed on the Return Form.
- Routing instructions for the cartons are as follows:
 - Section A Cartons without a store address label. See Exhibit I for an example. The cartons have a bar code label that shows the ship to address as Jonesville, NC.
 - Step 1. Complete the Return Form with the 20-digit carton number and email to the addresses listed on the Return Form. Jonesville will email you a copy of the shipping label.
 - Step 2. Upon receipt of the shipping label, attach it to the carton.
 - If the store is located outside your delivery area, ship the carton with the next scheduled delivery to the designated division in Barceloneta, PR.
 - If the store is located within your delivery area, the carton is to deliver with the next delivery for that store.



- > Section B Cartons without any label. See Exhibit J for an example.
 - Step 1. Complete the Return Form with a FedEx International Economy tracking number.
 - Step 2. Place the yellow Return Label (supplied by Jonesville) on the carton and ship it via FedEx International Economy to the Jonesville Distribution Center within 24 hours.

When shipping FedEx International Economy, all other labels should be blacked out or covered prior to shipment. The PVH barcode on the original shipping label must remain intact.

Section C – Misloaded cartons – Forward to the store. See Exhibit K for an example.

Step 1. Complete the Return Form with the 20-digit carton ID number, date, and the pro number you will be using to ship the carton to the designated division in Barceloneta.

- > Provide the FedEx International Economy tracking number on the Return Form.

- Complete the Hub Return Form with the 20-digit carton ID number, date, and the pro number you will be using to ship the carton to the designated division in Barceloneta.
